

Special District website trends

Section 508: new guidelines went into effect Jan. 18, 2018.
(Streamline is one of the few platforms that complies.)



Florida: Special District Accountability Program, all special districts required to have websites by Jan. 2015 (with 42 posting requirements!)

Illinois: bill will require all local government with a budget over \$1M to have a website, including 14 transparency items.

Missouri: state auditor is testing local gov and calling for transparency

California: all districts required to have websites, including five posting requirements.
